

- 6) No Mobilization Advance and Secured Advance will be allowed.
- 7) There shall be no provision of Arbitration. Hence clause 25 of 2911 (ii) is omitted vide notification no. 558/SPW dated. 3.12.2011 of Principal Secretary, P.W. & P.W. (Roads) Department.
- 8) The Bidder, at the Bidder's own responsibility and risk is encouraged to visit and examine the site of works and its surroundings and obtain all information that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice inviting Tender, the cost of visiting the site shall be at the Bidder's own expense. Traffic management and execution shall be the responsibility of the Agency at his/her/their risk and cost.

- 9) No CONDITIONAL/ INCOMPLETE TENDER will be accepted under any circumstances.
- 10) The provisions of the Prohibition of Employment as Manual Scavengers and their Rehabilitation Act 2013 should be strictly complied by the Bidder.


