And whereas, it is necessary to prevent any untoward incident in and around of Examination Venues.

I, Shri Pushpendu Sarkar, Sub-Divisional Executive Magistrate Sadar (North), Purba Bardhaman in exercise of power conferred upon me, do hereby promulgate this Order under Section 144 of the Criminal Procedure Code, 1973, prohibiting:


1. Assembly of 5 (five) or more persons.
2. Carrying of Fire Arms, Banners, Lathis, Spears, Swords, Sticks, Brickbats etc.
3. Shouting around the Center.
4. Such other activities which may disturbs the process of Examination.
5. Use of any Mobile phone or pager in the Examination Hall by the Examinees.
6. Opening of any Xerox Machine/ Photocopy shop in the vicinity of the Venues (within 200 metres radius of the venue) from 10:00 a.m onwards of the Examination dates till the completion of the entire process.
7. Use of Micro phone / Loud Speaker.



This Order shall come into force with effect from 10:00 a.m on examination date, till the completion of examination process.

Any person contravening this order shall be punishable under Section 188 IPC.

As the order cannot be served individually upon all concerned, the order is hereby passed ex-parte. It will be published for the information of public by affixing copies on the notice board of the Offices of the District Magistrate, Purba Bardhaman, Sub-Divisional Officer, Sadar (South), Purba Bardhaman, Sub-Divisional Officer, Sadar (North) Purba Bardhaman, Police Stations and all the Examination Venues.


