Scope of Works: -

- A. Secondary Collection & disposal of Municipal solid waste from different ward at Burdwan Municipality on day to day basis by using following Vehicle and Manpower and Equipments :-**

- The Collection will be done from the waste points till all the garbage are removed / cleaned. The collection of waste is to be started in morning shift form 8AM and till all the vats are cleaned in the route till all the vats are cleaned in the route as mention. Agency has to deploy required number of Vehicles in the route for the purpose of pulling the trolleys.

- The rates should be inclusive of all maintenance cost of trolleys which are provided by this Municipality for the trolley vats only at the route in the enclosed schedule as described in Annexure I, viz. Body repairing Hydraulic works, Vulcanization of Tyre Tube, Greasing & Washing charge, stag, hops, drum, paints, welding works etc.
- B. Eligibility criteria for participation in Tender :-**

 - iv) Neither prospective bidders nor any of constituent partner had been debarred to participate in tender by any Department during the last 2 (two) years prior to the date of this NIT. Such debar will be considered as disqualification towards eligibility. (A declaration in this respect has to be furnished by the prospective bidders as per prescribed format without which the Technical Bid shall be treated non-responsive).
 - v) Registered Co-operative Societies are required to furnish valid Bye Law, Current Audit Report, and Valid Clearance Certificate from A.R.C.S. along with other relevant supporting papers. [**Statutory Documents**]
 - vi) A prospective bidder shall be allowed to participate in the Job either in the capacity of individual or as a partner of a firm

4. There shall be no provision of Arbitration.

5. No. price preference and other concession will be allowed.

6. **Earnest Money:** As per Annexure-(A), as an initial Earnest Money Deposit shall accompany with Bid Proposal, shall be paid by online internet bank transfer or NEFT or RTGS (as per GO No. 3975-F(Y) dt. 28.07.2016 of Finance Department., Govt. Of West Bengal). Every such Transfer shall be done on or after the date of publish of NIEB. Any Bid without such Transfer of EM (Except exemption as per G.O.) shall be treated as informal and shall be automatically cancelled. Online transfer of Earnest Money receipt has to be uploaded as Statutory document. (Scanned copy) Earnest Money Deposit i.e. 2% [Rs. – 5, 53, 180/-(Five Lakh Fifty Three Thousand One Hundred Eighty Only as per yearly basis)]. **The earnest money of successful bidder will have to be converted into security deposit.**

7. **Security Deposit:** The Security Deposit will be at a rate of as per yearly basis of 10% of the contract value shall be deposited by the successful bidder. Successful bidder shall have to submit a security deposit valuing 8 % [approximately Rs. – 22, 12, 719 /-(Twenty Two Lakh Twelve Thousand Seven Hundred Nineteen Only)] of the contract value in addition at the time of execution of agreement in the form of DD / Pay Order / Bank Guaranty.

8. The Bidder, at the Bidder’s own responsibility and risk is encouraged to visit and Examine the Site of the Municipal Vats and Municipal dumping ground to obtain all information that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice Inviting Tender, the cost of visiting the site shall be at the Bidder’s own expense.

9. The prospective bidder shall have to execute the work in such a manner so that appropriate service level of the work is maintained during tenure of work and the contract will be for a period of 1(One) year from the date of issuance of the work order to the successful agency/agencies .Refund of Security Deposit will only be made after successful maintaining of appropriate service level of the work as mentioned above for the entire tenure.
10. The Contract shall commence from the date as mentioned in the work order and will be valid up to a maximum period of 1(One) year initially, the order may be renewed for further 1(One) year and subject satisfactory performances in the same rate, terms & conditions.
11. **N.B. In addition Bonus must be paid by the agency as per latest Government Order before Eid and Durga Puja. This amount will be reimbursement to the agency after proper document.**
12. The intending Bidders shall clearly understand that whatever may be the outcome of the present invitation of Bids, no cost of Bidding shall be reimbursable by the Chairman, Burdwan Municipality reserves the right to reject any offer without assigning any reason whatsoever and is not liable for any cost that might have incurred by any Bidder at the stage of Bidding.
13. **Refund of EMD:** The Earnest Money of the entire unsuccessful Tender deposited in favour of Chairman, Burdwan municipality will be refunded by the Chairman, Burdwan municipality on receipt of application from bidder after completion of Tender process in all respect.
14. Prospective Bidders are advised to note carefully the minimum qualification criteria as mentioned in ‘Instructions to Bidders’ before bidding.
15. In case of ascertaining authority at any stage of application or execution of work necessary registered power of attorney is to be produced.
16. No **CONDITIONAL/ INCOMPLETE TENDER** will be accepted under any circumstances.
17. The Chairman, Burdwan Municipality reserves the right to cancel the N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained.
18. During scrutiny, if it comes to the notice to tender inviting authority that the credential or any other papers found incorrect/manufactured/fabricated, that Bidder will not be allowed to participate in the Tender and that application will be out rightly rejected without any prejudice.
19. Before issuance of the work order, the tender inviting authority may verify the credential & other documents of the lowest Bidder if found necessary. After verification, if it is found that such documents submitted by the lowest Bidder is either manufacture or false in that case, work order will not be issued in favour of the Bidder under any circumstances.
20. The agency will have to collect the segregated waste as well as mixed waste from different vat points of Burdwan Municipal area.
21. If any discrepancy arises between two similar clauses on different notifications, the clause as stated in later notification will supersede former one in following sequence:-

INSTRUCTION TO BIDDERS

SECTION – A

1. General guidance for e-Tender

Instructions/ Guidelines for tenders for electronic submission of the tenders online have been annexed for assisting the contractors to participate in e- Tender.

2. Registration of Contractor/Agency

Any Contractor/Agency willing to take part in the process of e-Tendering will have to be enrolled & registered with the Government e-Procurement system through logging on to <https://etender.wb.nic.in>(the web portal of public works department) the contractor is to click on the link for e-Tendering site as given on the web portal.

3. Digital Signature certificate (DSC)

Each Contractor/Agency is required to obtain a class-II or Class-III Digital Signature Certificate (DSC) for submission of tenders, from the approved service provider of the National Information's Centre (NIC) on payment of requisite amount details are available at the Web Site stated in Clause 3 DSC is given as a USB e-Token.

4. The Contractor/Agency can search & download NIT & Tender Documents electronically from computer once he logs on to the website mentioned in Clause 2 using the Digital Signature Certificate. This is the only mode of collection of Tender Documents.

5. Submission of Tender.

General process of submission, Tender is to be submitted through online the website stated in Cl. 2 in two folders at a time for each work, one in Technical Proposal & the other is Financial Proposal before the prescribed date & time using the Digital Signature Certificate (DSC) the documents are to be uploaded virus scanned copy duly Digitally Signed. The documents will get encrypted (transformed into non readable formats).

- iii. Decrypted (transformed in to readable formats) documents of the non statutory cover will be downloaded & handed over to the tender evolution committee.
- iv. Uploading of summary list of technically qualified Bidders.
- v. Pursuant to scrutiny & decision of the screening committee the summary list of eligible tenders & the serial number of work for which their proposal will be considered will be uploaded in the web portals before 48 hours of opening of financial bid.
- vi. While evaluation the committee may summon of the tenders & seek clarification / information or additional documents or original hard copy of any of the documents already submitted & if these are not produced within the stipulated time frame, their proposals will be liable for rejection.

8. **Rejection of Bid**

The Chairman, Burdwan Municipality reserves the right to accept or reject any bid and to cancel the bidder process and reject all bids at any time prior to the award of contract without there by incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders of the ground for Employer’s action.

9. “**Any intending bidders** who have failed to execute more than one works contract under any Directorate of this Department and was terminated by any sub rule under clause 3 of Tender Form No.2911 or terminated under any clause of Standard Bidding Document by the Engineer-in-charge/Employer during last 3(three) years will not eligible to participate in any bid under any Directorate under this Department for another 2(two) years from the date of imposition of last termination notice by the Engineer-in-charge/Employer.”

10. AWARD OF CONTRACT

The Bidder who's Bid will be accepted, He / She will be notified by the Tender Inviting & Accepting Authority through acceptance letter.

11. The Contractor will submit the Monthly bill after satisfactory completion of said work. The Municipal Authority will pay the bill after verification of the said work.

12. The Agency has to clean all the vats on land as well as on the trolley in morning shift as mention in **Annexure - 1** by their own vehicle / machinery and manpower also submit work done statement / report to SWM department by their supervising staff daily afternoon . In case of non compliance charges will be deducted from concerned agency at the following rate.

A. In case of Land Vat: Rs. 2000.00 per vat per day.

B. In case of Trolley Rs.1000.00 per vat per day.

13. The Agency will quote his rate inclusive of labour wages, statutory benefits (PF AND ESI) and cost of equipments and all taxes & duties as applicable. No escalation of offer rate will be allowed during the period of contract.

14. N.B. In addition Bonus must be paid by the agency as per latest Government Order before Eid and Durga Puja. This amount will be reimbursement to the agency after proper document.

15. The Municipal Authority will not be liable any way for payment of wages and statutory benefits of the labour forces engaged by the agency for his /her day to day work.

The notification of award will constitute the formation of the Contract.

The necessary closes mentioned in the Agreement will be incorporate all the important clauses between the Tender Accepting Authority and the successful Bidder. All the tender documents including NIT & BOQ will be the part of the contract document and arbitrator clauses will be there for avoiding any future complications.
